- Eligibility:** Open to all junior club and sanctioned racers J6-Masters (ages 6 and up).
******* Helmets required *******
- Seeding:** By age classification. Youngest to oldest by class.
- Entry Deadline:** Wednesday, February 17, 2010. Complete entries must have athlete signature and payment. Entry fee must accompany the entry form. Faxes without payment are not complete. Contact the race administrator if you have questions.
- Late Entries:** **Entries submitted after the posted deadline or incomplete entries will be subject to a \$10.00 late fee per race.**
- Liability Releases:** The bottom half of the race entry form is the liability release. All athletes, regardless of age, must sign the liability release.
- Race Headquarters:** Mt. Ashland Lodge on the fourth floor.
- Spaghetti Feed:** *All skiers and their families are welcome to join us at the 3rd Annual MARA Spaghetti Feed on the second floor of the Lodge. Dinner will include spaghetti, salad, garlic bread & a soft drink. The cost of \$8 per person must be paid with entry fees. Seating is limited to 50.*
- Registration:** Opens at 8:00 am each morning on the fourth floor of the Lodge. Follow the stairs to the top. Liability releases and late fees must be turned in before a bib is issued.
- Lift Passes:** 6 years and under free, 7 to 17 for \$24.00, 18 to 64 for \$31, 65-69 for \$24, 70 and over are free. *Coaches of visiting teams shall receive one complimentary ticket for each 8 paid athletes.* Registered racers can purchase discounted racer tickets at the ticket counter on the first floor from 8 am to 9 am from Mt. Ashland. (Check, Cash or Bankcard). *****Prices may change ... these prices are a guide.*****

I further agree to RELEASE FROM LIABILITY and to INDEMNIFY AND HOLD HARMLESS the organizers of this program MT ASHLAND RACING ASSOCIATION, MT ASHLAND ASSOCIATION d.b.a. SKI ASHLAND and their owners, agents, landowners, affiliated companies and employees from any and all claims by or on behalf of myself and or the participant arising out of or related to racing, training, instruction, conditioning, use of ski area premises or facilities, and or travel to and from activities, including any and all loss, claim or damage resulting from or occurring due to participant's failure to have and or wear a helmet which is required to participate in a MARA sponsored event.
